

Restricted Resident Parking Permit allows resident's vehicle to park in guest parking stalls nearest to resident's unit in the following areas: Via Presidio and Via Santiago (excluding four (4) stalls near cul-de-sac); Via Inez and Via Portola (excluding four (4) stalls at end of Via Portola near mailboxes); Via Canon, Via Sonora.

I understand that:

- 1. Quantity of permits is limited. Permits are assigned on a first come, first served basis. A new application must be submitted each year upon permit expiration.
- 2. Limit of one permit per unit.
- 3. Permit is valid ONLY in guest parking stalls designated nearest to my unit.
- 4. Vehicle must be in regular use not being stored.
- 5. If vehicle is parked in wrong area four times, permit is automatically revoked with no refund.
- 6. Vehicle must be registered to this RDTA unit address.
- 7. Permit is a sticker applied to the outside lower left corner of rear window of the vehicle.
- 8. Permit sticker may not be transferred to another vehicle.
- 9. Annual processing fee is one hundred fifty (\$150) dollars if sign up between December 1, 2013 May 30, 2014; seventy-five (\$75) dollars if sign up between June 1, 2014 November 30, 2014.
- 10. Check made out to RDTA must be from legal owner of this unit.
- 11. Permit is valid for up to one (1) year expiring on November 30 & must be removed when expired.
- 12. Legal owner must sign this application.
- 13. A member of the RDTA Parking Committee will verify that the vehicle meets qualifying criteria.
- 14. Vehicle must NOT be a RV, boat, trailer of any kind, vehicle that may be used for commercial purposes, vehicle displaying the name of a business, modified vehicle, off road vehicle, or vehicle with bottom of frame over 20 inches off ground. (Contact the Parking Committee if you need clarification.)
