**I understand that:**

1. A member of the RDTA Parking Committee will verify the information provided and that vehicle meets all qualifying criteria.
2. Request will be evaluated against the current RDTA parking rules and regulations.
3. All vehicles and drivers must be registered to this RDTA unit address.
4. Vehicle must be in regular use – not being stored.
5. Permit is a sticker applied to the outside lower left corner of rear window of the vehicle.
6. Permit sticker may not be transferred to another vehicle.
7. Permit authorizes vehicle to park in any RDTA guest parking stall.
8. Annual processing fee is fifty (\$50) dollars if sign up between December 1, 2013 – May 30, 2014; twenty-five (\$25) dollars if sign up between June 1, 2014 – November 30, 2014.
9. Check must be from owner of unit and made out to RDTA.
10. No matter when sign up, permit expires on November 30, 2014 & must be remove.
11. A new application must be submitted each year upon permit expiration and requires re-verification of qualification.
12. Legal owner of this unit must sign this application.
13. Vehicle must NOT be a RV, boat, trailer of any kind, vehicle that may be used for commercial purposes, vehicle displaying the name of a business, modified vehicle, off road vehicle, or vehicle with bottom of frame over 20 inches off ground. (Contact the Parking Committee if you need clarification.)
