II. USE AND ARCHITECTURAL RESTRICTIONS

Q. Pool and Wading Pool

- 1. The pool shall be open daily from 8:00 AM to 10:00 PM and the gate shall be locked at ALL TIMES. Climbing the fence is prohibited.
- 2. All guests shall be accompanied by an adult resident. A maximum of five (5) non-resident guests are allowed in the pool area without the prior written approval of RDTA.
- 3. No lifeguard is on duty and all persons using the pool area shall be responsible for the safety of themselves, their family members, and their guests.
- 4. To the fullest extent permitted by law, children under fourteen (14) years of age are not permitted in the pool unless directly supervised by a parent, legal guardian or other adult (age 18 or older).
- 5. The use of the pool and wading pool on a first-come, first-served basis.
- 6. Any person having any apparent skin disease, sore, or inflamed eyes, cough, cold, nasal or ear discharge, or any communicable disease shall not use the pool or wading pool during such period of illness. Persons having currently active diarrhea or who have had active diarrhea within the previous fourteen (14) days shall not be allowed to enter the pool or spa water.
- 7. No food is allowed in the pool or wading pool.
- 8. No bicycles, skateboards, scooters, glass of any kind, or metal objects are allowed in the pool area.
- 9. Diving, horseplay, running, dunking, and loud and/or disturbing noise is prohibited. Sound amplifying devices that can be heard by others, such as speakers, are prohibited. Headphones and earbuds are allowed.
- 10. Use of the pool or wading pool facility while under the influence of alcohol, drugs, narcotics or medicines is prohibited.
- 11. Persons using suntan oils, lotions or cremes must shower before entering the pool or wading pool.
- 12. Proper swim attire must be worn. No cut-offs allowed.
- 13. No glassware or Styrofoam (drinking containers, bottles, serving dishes, etc.) is allowed in or around the pool area. Only non-breakable plastic is permitted.
- 14. All persons are responsible for removing everything brought with them to the pool area upon leaving. There should be nothing left behind in the pool area, including trash and personal items like towels, pool floats, toys, etc. Trash receptacles may only be used for small trash items.
- 15. RDTA pool furniture must remain in the pool area and be returned to their original placement after use.
- 16. Unless posted otherwise, a maximum of sixty (60) people are allowed in the pool and a maximum of six (6) people are allowed in the wading pool at one time.
- 17. Misuse of equipment or facilities is prohibited.
- 18. Residents are permitted to hire a swim instructor and use the pool with the swim instructor only with advance written approval by the Board. Residents must contact the management company to receive and submit a completed form for consideration. Swim instructors are required to have liability insurance and proof of insurance must be submitted with the form. Non-residents are not permitted to receive swim instruction in the pool.
- 19. Any problems regarding the pool or wading pool should be reported to RDTA's community manager.
